## **Confidential Annexes**

The Confidential Annexes to the reports of the Intelligence Services Commissioner between 2010 and 2014 have been disclosed in redacted form. Some of the redactions have been made on the grounds of relevance and in one instance on the ground of LPP. Where text has been redacted for reasons of national security a gist has been provided, although this has not always been possible. Where a gist of the redacted text can be given it is set out in the table below.

## Numbers of BPDs

A number of the redactions relate to text concerning numbers of BPDs held by the Security and Intelligence Agencies, disclosure of which would be damaging to national security. In respect of the same, however, the Respondents confirm as follows:

The combined number of BPD datasets held by GCHQ, MI5 and SIS is numbered in the hundreds. This total number is constantly fluctuating as datasets are acquired and deleted, but the trend over recent years has been one of growth in the number of datasets held. Many of the same datasets are held by more than one agency.
