We have been provided with an SIA Inspection Report 2015 in respect of an inspection dated 24 June 2015, which includes a section entitled "Referral to the Crown Prosecution Service" that is redacted in its entirety. Please provide an explanation for that redaction (explaining, for example, whether this section of the Inspection Report details a specific referral to the CPS or a statement of policy, and in any event the grounds upon which it has been redacted and a gist of the contents).
- 4. Paragraph 2 of the Security Service Policy on Running Agents in Serious Crime refers to "Home Office Circular 97/1969", which is said to "contain...
