

# **LEDS and HOB Open Space:**

## **Open Space – the future v1.0**

26 February 2019

### **Discussion Document**

This Document has been written to stimulate discussion on the governance for LEDS and HOB. It is not a statement of Home Office policy or intention. It is to be circulated to and viewed only by members of the LEDS and HOB Open Space.

## Introduction

1. The Home Office wants to build upon the start of the Open Space and establish a new way of engaging with Civil Society in relation to Home Office Policing and law enforcement programmes. This paper sets out key points which form part of the Home Office's vision for that engagement and invites Open Space members to consider:
  - Whether this is a concept that will deliver value for all parties,
  - Whether this is something members individually would like to be part of and;
  - What changes would be worth considering.
2. This paper draws on the engagement to date in the Open Space since the first meeting in 2018.
3. **We have heard...**
  - i. Members wanted more strategic conversations covering a greater range of programmes whilst still having the ability to reach into specific issues. What started out as a desire to ensure that we had a greater range of inputs into the LEDS (Law Enforcement Data Service) privacy impact assessments, developed into a request to explore the programme more widely. To do so Members made clear that we needed to have broader conversations covering different programmes. In the last meeting we introduced HOB (Home Office Biometrics). This has expanded the scope of discussions. Where it makes sense the Home Office in consultation with Open Space Members will seek to expand the scope of topics under discussion.
  - ii. That custody images are a significant concern for some members of the Open Space. The issue of the retention of custody images of those found not guilty has been the subject of frequent discussion. The latest position paper on custody images hopefully demonstrates that we have taken these concerns on board and substantive changes to our approach will follow.
  - iii. That changes needed to be made to the aims of the Code of Practice (Code). The Code needed to focus more on accountability and explicit references to Human Rights were needed. Other changes such as including whistleblowing guidance and a public consultation on the Code will also be included in future work around this area. The drafting of the Code has started and will be discussed at the May Open Space workshop.
  - iv. We need to better ensure fairness relation to Evidence. We need to ensure defence (and prosecution) understanding of data being presented, particularly in relation to best evidence. We will summarise our thoughts in this area for those Open Space members that have concerns around evidential presentation.

- v. The investigation, prosecution and rehabilitation of harassment and stalking offenders is hampered by not having the appropriate information recorded and available for subsequent incidents or for probation officials. We will work with those interested Open Space members to build the appropriate pathways for recording information, whilst bearing in mind the alternate concern about data minimisation and rights to be forgotten.
- vi. The retention of older records and information about less serious offences is being questioned in relation to the impact it has on offenders. The retention project is looking at how to minimise data aligned with maintaining operational priorities.
- vii. The Data Protection Impact Assessment (DPIA) needs to build upon the 2017 Privacy Impact Assessment and deliver on the concerns Civil Society raised at that time and since. The challenge of writing a DPIA that documents and does justice to those concerns is complex. We have therefore determined we needed to bring in a dedicated full-time resource to write the DPIA by September 2019. That person starts in March.
- viii. This is a significant commitment from Civil Society Members and therefore there is a concern to make it as meaningful as possible. The pace of progress could be faster and that papers are not always issued with sufficient time to enable proper digestion prior to meetings must be improved. We are looking into changing the way that we are organised and are recruiting to provide dedicated policy resources to start as soon as possible to tackle these issues in future.

4. In relation to the Open Space in general we are proposing:

- i. The Open Space maintains its meeting frequency,
- ii. Involve continues to maintain the Open Space,
- iii. That Open Space members register their interests against which they desire to see progress,
- iv. There is an annual “Open Space” report compiled by academics/civil society covering those interests as outlined in the Governance Discussion Paper for this workshop too,
- v. The Open Space, through Involve, commissions this annual report but maintains its independence by not writing it,
- vi. There are periodic Home Office Ministerial meetings where Involve with representative interested members of the Open Space can discuss issues and progress.

5. In relation to the LEDS specifically, the Home Office is proposing the multi-year timeframe in Appendix A as shared in the Governance Discussion Paper.
6. **Key question: The Home Office is keen for feedback on these proposals, in particular what additional changes might be needed to continue the Open Space beyond May 2019?**
